BYLAW NO. 5/1991

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE PROVISION OF FIRE PROTECTION SERVICES.

The Council of the R. M. of Harris No. 316 in the Province of Saskatchewan, enacts as follows:

1. The R. M. of Harris No. 316 is hereby authorized to enter into the agreement, attached hereto and forming part of this Bylaw, and identified as 'Exhibit A', with the following municipalities:

Village of Harris

R. M. of Marriott No. 317

for the purpose of providing and/or receiving fire protection services.

2. The Reeve and Administrator of the R. M. of Harris No. 316 are hereby authorized to sign and execute the attached agreement identified as 'Exhibit A'.

THE VILLAGE OF HARRIS, in the Province of AMONG: Saskatchewan, of the First Part, hereinafter referred to as 'The Village'

- and -

THE RURAL MUNICIPALITY OF HARRIS NO. 316, in the Province of Saskatchewan, of the Second Part, hereinafter referred to as 'RM 316'

and -

THE RURAL MUNICIPALITY OF MARRIOTT NO. 317, in the Province of Saskatchewan, of the Third Part, hereinafter referred to as 'RM 317.

WHEREAS the Village and RM 316 maintain a Fire Department for the provision of fire protection within their boundaries, known as the 'Harris & District Fire Department', and,

WHEREAS RM 317 wishes to arrange for the Village and RM316 to provide fire protection services to the residents of RM 317,

NOW THEREFORE in consideration of the premises, conditions, covenants, and provisions hereinafter contained and set forth, the Village, RM 316, and RM 317 agree as follows:

- 1. The Village and RM 316 shall provide fire protection services to RM 317, to the best of their ability.
- 2. In the event that fires occur simultaneously within RM 317 and either The Village or RM 316, first response shall be to the Village or RM 316 as the case may be.
- 3. All fire calls originating from RM 317 shall be billed, at rates currently in force at the time of the call, to the person responsible for the said call. In the event the charge is not paid, RM 317 hereby agrees to pay the full amount of the charge to The Village.
- 4. The Harris & District Fire Deptartment, The Village and RM 316 shall be held harmless from any liability arising out of fire protection services provided to RM 317.
