

BYLAW NO. P133/1981

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE JOINT FUNDING OF FIRE FIGHTING EQUIPMENT.

The Council of the Rural Municipality of Harris No. 316, in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Harris No. 316 is hereby authorized to enter into the agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "A", with the following municipality:

Village of Harris

for the purpose stated within the agreement.

2. The Rural Municipality of Harris No. 316 is hereby authorized to enter into the agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "B", with the following municipality:

Village of Tessier

for the purpose stated within the agreement.

3. The Reeve and Secretary-Treasurer of the Rural Municipality of Harris No. 316 are hereby authorized to sign and execute the attached agreements identified as Exhibit "A" and Exhibit "B".

EXHIBIT "A" TO BYLAW NO. P133/1981

Memorandum of Agreement made this 6 day of APRIL 1981 A.D.

Between: Rural Municipality of Harris No. 316
Village of Harris

This agreement witnesseth as follows:

1. The parties to this agreement shall share the costs involved with the purchase, maintenance and upkeep of required fire fighting equipment at the following rates:

Village of Harris - 51% share
R. M. of Harris No. 316 - 49% share

2. Any expenditure in excess of \$250.00 must be authorized by the councils of both municipal bodies.

3. The R. M. of Harris No. 316 and the Village of Harris agree that the fire fighting equipment mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of each municipality on an equal opportunity basis.

4. The housing of the said fire fighting equipment shall remain the responsibility of the Village of Harris.

R. M. of Harris No. 316 - 49% share

2. Any expenditure in excess of \$250.00 must be authorized by the councils of both municipal bodies.

3. The R. M. of Harris No. 316 and the Village of Tessier agree that the fire fighting equipment mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of each municipality on an equal opportunity basis.

4. The housing of the said fire fighting equipment shall remain the responsibility of the Village of Tessier.
